2024 Impact

In 2003, Delta Dental of Kentucky (DDKY) established the Delta Dental of Kentucky Foundation. Since 2003, more than \$25 million has been distributed to non-profit organizations in Kentucky, with 70% of annual donations directly funding dental treatment and oral health education.



\$1,514,000 Dental Treatment

The Delta Dental of Kentucky
Foundation is dedicated to improving oral health across the Commonwealth. In 2024, \$1.5 million was provided for dental treatment. Supported organizations provide essential dental care, oral health education, and community services for at-risk and in-need populations. Through strong partnerships, this funding is making quality dental care more accessible for those who need it most.

- \$4,033,856 in care provided by 42 non-profit dental clinics and partners funding dental treatment
- Every \$1 donated = \$3.38 in provided care
- 13,762 unpaid hours volunteered by dentists, hygienists and dental assistants




2024 Dental Care by the Numbers











DDKY Employees Give Back

Delta Dental of Kentucky's unique Employee Giving
Program empowers team
members to make a meaningful impact in their communities.

Each year, employees are provided \$1,000 to donate to the non-profit of their choice. Eligible recipients include 501(c)(3) non-profits, schools and churches in Kentucky—or Indiana for employees living in Indiana.

In 2024, DDKY employees donated \$80,000 to 74 local organizations. Supported causes include the American Cancer Society, Dare to Care, and Alley Cat Advocates.



Mouthguards for Kentucky Students

In 2024, Delta Dental of Kentucky provided **free**, high-performance athletic mouthguards to student athletes across the state. Designed for superior impact absorption and ADA-accepted, these mouthguards also fit over braces to ensure comprehensive protection.


77,502 mouthguards, valued at \$1.94 million, were distributed to schools, teams, and sports clubs. In 2024, the program expanded to include 110 of Kentucky's 120 counties, reaching 11 more counties than the previous year's total of 99. The program will return in 2025 for a third year, offering mouthguards at no cost to student athletes.

New Dental School in Central Appalachia

Delta Dental of Kentucky has committed \$2,350,000 over 4 years toward the opening of University of Pikeville's College of Dental Medicine. This gift to help create a new dental school is the largest gift in history of the Foundation.

The Tanner College of Dental Medicine at the University of Pikeville is committed to providing essential dental care to adults, children and vulnerable populations, including those with special needs.

Brian Hart, vice president and chief revenue officer of Delta Dental of Kentucky, said the donation was, in part, provided with the hope of inspiring more young people to become dentists and stay in the area.

"That changes lives; it changes the economic trajectory of the area," Hart said, pointing out that people who receive their degrees at UPike tend to stay in the area to use their degrees and skills learned.

Funding from DDKY will help support the following four areas:

Furnishings

Includes all furnishings necessary, exclusive of equipment, for the dental college **Digital equipment**

Includes 6 intraoral scanners with 3D imaging, 6 3D printers and 3 intraoral lasers

Pediatric specialty clinic equipment

Includes dental chairs, lighting, delivery systems, central treatment columns, stools, intraoral tubeheads, intraoral sensors and USB interfaces for 6 operatories **Scholarship support**

Funding for multiple student scholarships
